<b>1</b>	<p><b>Election of Mayor</b></p> <p>Councillor Taylor, the current Mayor, spoke about completing his third year as Mayor and how he has used this as an opportunity to promote Blyth, whether it be a function or the opening of a shop, working with a foodbank or raising funds. Whilst some people don't like the idea of a Mayor, many do, and the main aim is to do the best for Blyth. Croftway Academy have the Mayor in their curriculum "People who inspire you in the Community". Recapping over the past 12 months the Mayor spoke of his first engagement, a visit to the Blyth Family Hub on Wright Street, and his last engagement was on a wet Bank Holiday Monday doing a litter pick at Crofton field. There are many highlights to recall including the Queen's Platinum Jubilee and the Coronation of King Charles.</p>

	<p>Blyth Town Council also renewed their Charter with Solingen, celebrating the 60-year anniversary in 2022. A group are visiting Solingen in the next week as part of the town twinning team.</p> <p>2022 saw the Council present the first Freedom of Blyth awards to Les and Margaret Welsh, Empire School of boxing and also had someone from the School of Boxing competing in the Commonwealth Games. The Mayor said he was delighted to present Councillor Aileen Barrass with the John Muir Award for some of the work she has carried out at Isabella.</p> <p>Looking forward to the next 12 months the Mayor talked about the Energising Blyth initiatives - hopefully work will be starting on the culture hub in June, the Council are continuing to develop the Neighbourhood Plan, there are two new play areas to be constructed and work around a new skate park is ongoing. Blyth Spartans celebrate their 125<sup>th</sup> anniversary in 2024.</p> <p>The Tall Ships project are awaiting a decision on their application for £5million from the heritage lottery fund and if successful will use the money to refurbish the Harbour Commissions Building as a Maritime museum. The Mayor reflected on his work in the foodbanks; people are really struggling and the cost of living crisis has hit people hard. Many people have recently visited the foodbanks, often for the first time, in an extremely distressed state, simply unable to cope.</p> <p>Councillor Potts nominated Councillor Taylor for the position of Mayor of Blyth Town Council. This was seconded by Councillor Reid.</p>

Recording of Council and Committee Meetings</li> </ol> <p>Discussion took place around the recent purchase of an “owl” system for use when holding hybrid meetings and whether this could be extended to recording Council and Committee meetings. Councillor Potts moved to accept the recommendation that the equipment is used to record meetings for a trial period in order to assess the quality of recordings etc. This was seconded by Councillor Nisbet. The Council voted on the motion with the result being 11 = for and 3 = against. There was one abstention.</p> <ol style="list-style-type: none"> <li>2. 	<p>Members noted the list of policies. Discussion took place around the amendments to the Risk Management Policy and the DTC answered queries. The Council <b>RESOLVED</b> to accept the amended policy.</p> <p>With regard to the Civility and Respect Policy there was some debate about whether the Council should sign the pledge, however, on reflection it was agreed that this should be done on an individual basis.</p> <p>Councillor Potts moved that the Council agree the policy and that individuals can sign up to the pledge should they so wish. A vote was taken with the results being 10 = for, 3 = against, 2 = abstentions.</p> <p>Investment Policy – the DTC explained the policy will enable BTC to be more flexible around any changes suggested to investments, giving it a more prudent approach. Members <b>RESOLVED</b> to accept the policy.</p>
<p><b>25</b></p>	<p><b>Register of Interests</b></p> <p>To remind Councillors of the need to regularly review and revise their personal Declarations of Interest. A request was made that members are reminded on a three-monthly basis to review their Declarations of Interest.</p>
<p><b>26</b></p>	<p><b>Any Other Business</b></p> <p>Members were asked to inform the Town Clerk which school they wished to be involved with in the presentation of medals.</p> <p><b>Energy Central</b></p> <p>The Mayor advised he has received a response to a letter written some time ago to the Chair of the Town Deal Board. The letter indicates that engagement with the partnership would provide the best means of ensuring BTC is engaged with the work of Energy Centre with a suggestion that representatives from BTC meet with Rob Strettle and Sarah McMillian, Assistant Service Director to look at how both groups can work together on the wider Energy Central agenda. It was proposed that the meeting should include the three Chairs of Committees, the Mayor and the Town Clerk. Members agreed with this proposal plus one Councillor from each of the political parties.</p>
